C. Gashdine, Lucinda Whitt, George Anderson and land now in possession of Anthony Donald, and being one half of a tract of land formerly owned by Jacob M Cooley deceased, and Hiram Cooley deceased, and known as the Pin Place, and being the half of said tract of land set off to Hiram & Cooley in the division of said tract of land made by said Hiram & Cooley and John Ballentine, the other half having been set off to said John Ballentine, in said division,

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in any-wise incident or appertaining.
