Green* and ending back into said *Musk Creek* road at a right *275* yards from where it left said road, the amount of land here by doing being $\frac{1}{4}$ of one acre, more or less, said strip of land being *2* miles or less said entire distance and is to be used by *Greenville County* as a right of way for a change made in the location of said *Musk Creek Road*.
