containing eight hundred and ninety five acres

members hereditaments and appurtenances to  
the said premises belonging or in anywise incident  
or appertaining.

To have and to hold all and singular the  
said premises unto the said Lillie M Hunter her  
heirs and assigns forever.

the said Greens Association or Body of G. N. O. of O. and  
their officers and successors in office the lot or parcel  
of ground, in the North West corner of Bethel Church  
lot, and the lot or parcel is 204.35 ft. Twenty feet wide  
and thirty feet long. All aforesaid real estate  
being situate in the County of Greenville and State  
of South Carolina.

Together with all the privileges and appurtenances  
thereto belonging. To have and to hold the above des-  
cribed premises for and during the term of Ninety  
Nine (99) years, from the date hereof.

And the Greens Association or Body of G. N. O. of O.  
and their successors in office, doth covenant  
and agree to let the said Trustees and their succe-  
sors in office use the ground floor of the Building  
for a School House gratis during the continuance  
of this lease. The said Greens Association or Body  
of G. N. O. of O. shall and do hereby have the privilege  
of moving their Building at any time and to any  
place they see proper to do, without molestation or  
interference from us, the Trustees of Bethel Church  
and our successors in office, and when they  
move the Building this lease becomes null and void.
