

- Courses and distances, to wit: Beginning on Court Street at James Shields line and running thence along Court Street east 37 1/2 feet, thence N 72 1/2 feet to McBees Spring lat, thence W 57 feet to James Shields corner, thence S 74 feet to the beginning on Court Street.
- (3) all that lot of land situate in the city of Greenville in the fifth ward on Gower Street, adjoining lands of Sally Tomax on the South, having a frontage on Gower Street of 57 feet and running back on parallel lines 409 feet to McBees line.
- (4) all that lot of land situate in the fifth ward in the city of Greenville on an alley immediately in the rear of lot sold to Hannie Kelly, said alley running from Gower Street to lots of Sally Tomax and Hannie Kelly, beginning at Hannie Kelly's corner on the alley, thence with her line 98 feet to Irvine's line, thence with Irvine's line 121 feet to stake, thence 98 feet to an 18 foot alley, thence along said alley 121 feet to the beginning.

- (6) That lot in fifth ward of said city on Gower Street measuring 50 feet on Gower Street by 217 1/2 feet deep, being lot of land formerly belonging to J. C. Gower and J. D. Donaldson and fully described in a deed from J. D. Donaldson to the executors of J. C. Gower, and containing 2 3/4 of an acre more or less.
- (7) Also that lot on Bessie Street in the city of Greenville measuring 55 feet on Bessie Street by 217 1/2 feet deep, containing 2 3/4 of an acre more or less, being a lot formerly owned by Gower and J. D. Donaldson, and fully described in a deed from J. D. Donaldson to the executors

- (8) That certain lot situate in the fourth ward in the city of Greenville on an alley running from Mardian Street to McBees Spring lat, bounded by said alley and lands of Dr. Latimer, W. H. Irvine and the Spring lat being a lot of land which was conveyed by Thomas Minis to J. C. Gower.
- (9) Also that lot situate in said city in the fifth ward on the west side of Means Street, and having the following meters and bounds, to wit: Beginning at a stake on Means Street, Mary Jane Green's corner, thence along Means Street N 27 1/2 E 50 feet to a stake Rebecca Lewis corner, thence N 77 W 46 feet to stake, thence S 27 1/2 W 50 feet to a stake Mary Jane Green's corner, thence with her line S 77 E 76 feet to the beginning, containing 3686 square feet, more or less.

- (11) all that certain lot of land situate in the fifth ward of said city on McCall Street, beginning at a stake on McCall Street, Margaret Butler's corner thence N 69 3/4 W 190 feet to a stake, thence N 20 1/4 W 180 feet to a stake on the Gower Street extension thence S 69 3/4 W 130 feet along Gower Street to Correlia Jennings corner, thence with her line S 20 1/4 E 120 feet to stake, thence S 69 3/4 W 60 feet to stake on McCall Street, thence S 20 1/4 E 160 feet to the beginning, and shown on plat by W. S. Slaughter as five lots.
- (12) all that lot of land situate in the third ward of said city on Hudson Street, between the lots sold to Baylis Halley and Horace Thompson having a frontage of 50 feet and running back in parallel lines 140 feet, containing 7,000 square feet, more or less.
