 at its own expense within thirty days after the expira-
 tion of this agreement.

(3) All dressed lumber and mouldings
 on hand by the party of the second part in the City
 of Greenville, South Carolina, is at any and at all
 times the property of the party of the first part.

This agreement is not negotiable
 or transferable.
