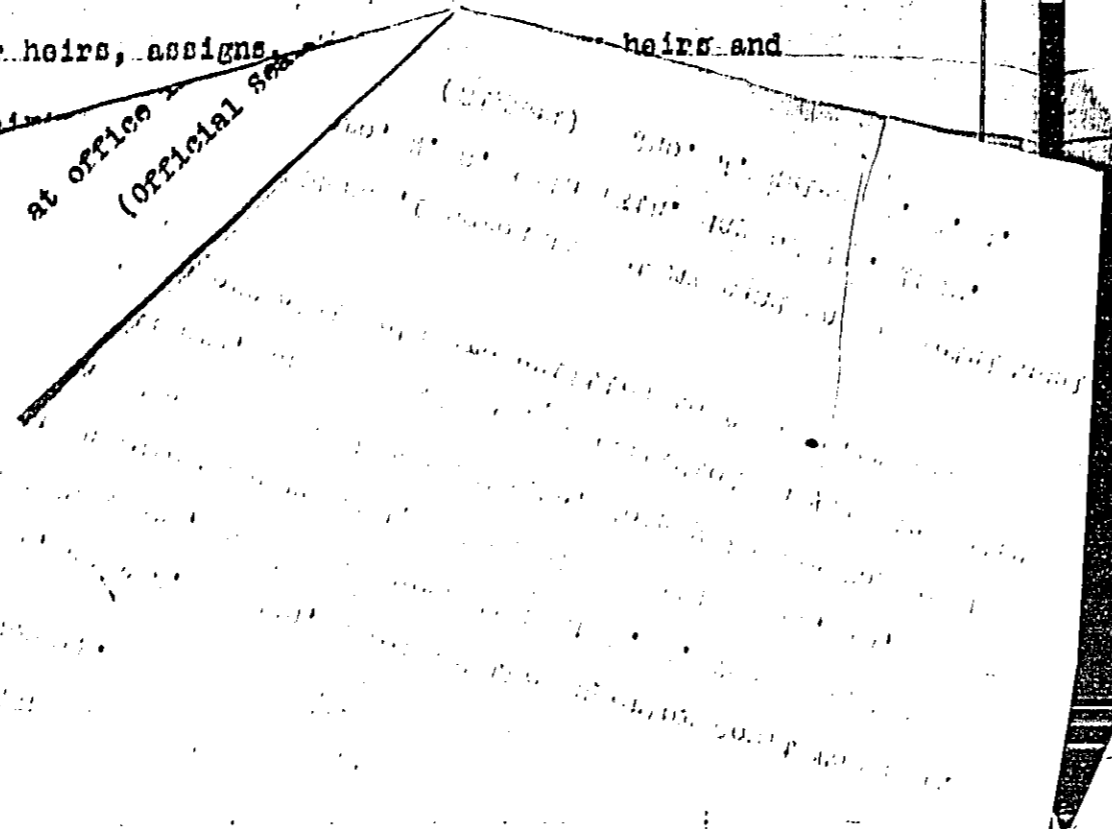

KNOW ALL MEN BY THESE PRESENTS:-

That we, Raymond L. Cruikshank, Frank W. Cruikshank, Neal B. Cruikshank
and W. N. Cruikshank, all residing in the City of Greenville, State of South Carolina
except the said Frank W. Cruikshank, who resides in the City of Decatur, State of
Illinois, in consideration of the love and affection we bear to our mother, Annie
S. Cruikshank, and in consideration of the payment by her of the mortgage debt now
on or against the land hereinafter described, and the sum of one dollar to us in
hand paid at and before the sealing of these presents by the said Annie S. Cruikshank
(the receipt whereof is hereby acknowledged), have granted, bargained, sold and re-
leased, and by these presents do grant, bargain, sell and release unto the said

Annie S. Cruikshank:-

All that piece, parcel and lot of land in the First Ward of the City of
Greenville, State of South Carolina, on the south side of Highland Avenue (formerly
known as West Street), near the intersection of said Avenue with Butler Avenue, and
known as the Cruikshank Lot, Beginning at a stake on West Street, now Highland
Avenue, and running with J. C. Orr's line two hundred feet more or less, to a stake,
thence in a line paralleled with Highland Avenue eighty feet to a stake on line of

land formerly owned by Broadway; thence along said line two hundred feet to a stake on High-
land Avenue, thence along said Avenue eighty feet to the beginning, being the same lot conve-
yed to our father William M. Cruikshank by Harleston Rutledge Walter and others, September
18th. 1888, see deed recorded in office of Register of Mease Conveyance for Greenville County
in Book W.W. page 109 et seq.

By this deed we convey all our right, title and interest as tenants in common of the
above described premises.

to the said premises belonging, or in any wise incident or appertaining.

And we do hereby bind ourselves, our heirs, executors and administrators to warrant
and forever defend all and singular the said premises unto the said Annie S. Cruikshank, her
heirs and assigns, against ourselves and our heirs, and against every person whomsoever law-
fully claiming or to claim the same or any part thereof.
