

Johnston, by deed bearing date April 18, 1903, having been sold under a decree of the Court of Common Pleas for Greenville County, bearing date November 21, 1884, rendered in a proceeding to partition all of said lands among the heirs-at-law of the said John T. Johnston, deceased, and having been conveyed in pursuance of said decree by S. J. Douthit, Master for Greenville County, to C. G. Drake and Myra Drake, by deed bearing date January 5, 1885, and recorded in the office last named on March 1, 1895. (1895), in Deed Book "B.B.B." at page 628; the said Myra Drake having thereto released unto the said C. G. Drake her undivided one-half interest in all of said lands, by deed bearing date December 31, 1885 and recorded in said office on November 6, 1901, in Deed Book "H.H.H." at page 310; Third, a tract adjoining lands of C. G. Drake, and Cleveland, containing one hundred and twenty-five (125) acres, more or less, conveyed by P. D. Gilbreath, Sheriff of Greenville County, to said C. G. Drake, by deed bearing date October 1, 1894, and recorded in last mentioned office on February 28, 1895, in Deed Book "Z.Z." at page 440; the said C. G. Drake having conveyed unto me the three tracts of land last described, containing in the aggregate one thousand and thirty-nine (1039) acres, by deed bearing date July 28, 1903 (the said deed conveying unto me the merchantable timber on said tracts of land, as aforesaid); together with the right of way over said tract of 1039 acres for the purpose of cutting and removing the said timber, and the right to use, free of charge, such smaller timber as may be necessary for building roads, bridges, etc. (all of which rights are also intended to be conveyed hereby);

Johnston of the City and County of Greenville in the State aforesaid, in consideration of the sum of thirty-one thousand, one hundred and twenty-two and 75/100 dollars, to me in hand paid at and before the sealing and delivery of these presents by Saluda River Lumber Company, a corporation duly chartered under and by virtue of the laws of the State of South Carolina (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Saluda River Lumber Company all those certain pieces, parcels or tracts of land situate, lying and being in the State of South Carolina and County of Greenville, containing in the aggregate twenty thousand, seven hundred and forty-eight and one-half (20748 1/2) acres, more or less, and described respectively as follows, to wit;

All that tract in Cleveland Township, containing twenty-nine hundred (2900) acres, more or less, Middle Fork of Saluda River, Matthew's Creek and Oil Camp Creek; this being the same tract of land granted by the State of South Carolina to George F. Townes, under warrant dated October 10, 1871 (see Location Book "B.B." page 147 in office of Register of Deeds for Greenville County, South Carolina); and which was sold to J. Walter Gray as the property of said George F. Townes by John... Southern, Sheriff of Greenville County, by decree of the Court of Common Pleas of Greenville County, dated October 10, 1872, and recorded in office of Register of Deeds Conveyance Book "A" page 147.
