C. Roessler, "All that piece, parcel and tract of land situate, lying, and being in the County of Greenville, and State aforesaid, on the Spartanburg Road, two (2) miles from Greenville C. H., and having the following lines, metes and bounds, to wit: Beginning at a stake 3X on the Spartanburg Road at N. E. Burgess corner and running thence with said road S. 50 W. 9.15 to a stone 3X in a bend of the road; thence still with the road S. 74 W. 1.89 to a stake; thence along the road S. 75 W. 3.04 to a stone on the road; thence still with the road S. 74 W. 6.50 to a persimmon tree; thence S. 75 1/2 E. 17.00 to a stake 3X; thence S. 44 1/2 W. 9.58 to a stake 3X; thence S. 47 1/4 E. 9.00 to a stake; thence N. 46 1/2 E. 2.65 to a stone 3X; thence N. 50 1/2 E. 3.16 to a poplar 3X; thence N. 78 1/4 E. 12.8 to a red oak 3X; thence N. 23 1/4 W. 8.30 to a red oak 3X; thence N. 55 W. 13.50 to the beginning corner, containing fifty five and seven tenths (55 7/10) acres, more or less, composing the four (4) adjoining tracts, which were conveyed by purchase from A.
