THE STATE OF SOUTH CAROLINA

EXECUTIVE DEPARTMENT BY THE SECRETARY OF STATE

Whereas, A. E. Boyd, M. M. Mouzon, A. B. Davis, J. O. Allen and J. C. Martin all of Greenville, S.C., did on the 8th day of Nov. 1904 file with the Secretary of State a written Declaration, signed by themselves, setting forth:

First: The names and residences of the said petitioners to be as above given.

Second: The name of the proposed corporation to be that of EUREKA-BENEVOLENT INSURANCE ASSOCIATION.

Third: The principal place of business of the corporation will be Greenville, S.C.

Fourth: The general purpose of the corporation and the nature of business it proposes to do, to provide a mutual protection or mutual Benevolent Insurance Company, mutually insuring its members by providing for the payment of benefits in case of death, sickness temporary or permanent physical disability, either as result of disease or accident, and to pay such insurance or benefits by assessing the members of said Company or Association the amount of such insurance or benefits, the manner of making assessments the amount and time of payment to the beneficiary or member all to be determined by the By-Laws of the Company or Association.

Fifth: The amount of the Capital stock to be one thousand dollars, and the number of shares into which the same is to be divided to be ten of the par value of one hundred dollars each.

Sixth: The capital stock to be payable as set forth in the Declaration.

AND WHEREAS, on Nov. 8th, 1904 the date above named, petitioners were com-mitted by me a Board of Corporators;

AND WHEREAS, the said board of Corporators on the 8th day of November, 1904 did file with the Secretary of State their return in writing, over their signatures certifying certain things, that pursuant to be published notice as required in the commission of the said

Corporators, the books of subscription to the capital stock of the aforesaid company were duly open and ready for inspection at the office of the Secretary of State.

was called and the aforesaid Company duly organized by the election of a Board of Directors, and other necessary officers. That furthermore they have complied with all the requirements of the Code of Laws of the State of South Carolina, of 1902 and all Acts or parts of Acts amendatory thereto;

Now, THEREFORE, I, J. T. Gantt, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purpose indicated in their written declaration, and that they are fully authorized under their charter and I hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance in each county where such Corporation shall have a business office.
