WHEREAS, F.F. Copers, Ellison A Smith, Lewis Park Parker, W.E. Beattie, H.J. -

Haynsworth, N.C. Pee, did on the 24th day of April, 1905 file with the Secretary of State a written Declaration, signed by themselves, setting forth:

FIRST: The names and residences of the said petitioners to be as above given.

SECOND: The name of the Proposed corporation be that of INTER-STATE TRUST COMPANY

THIRD: THE principal place of business of the corporation will be Greenville, S.C.

FOURTH: THE general purpose of the corporation, and the nature of business it proposs to do, a general trust company, brokerage and warehouse business; to lend money,

buy and sell exchange, stocks, bonds, and evidences of indebtedness, and other things of value, both real and personal; to negotiate loans of money, and guarantee the same;
