Above described lot being a part of the sub-division of the lands bought by said Company from L.C. Bolling. Together with all and singular the rights, Members, Hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. To have and to hold, all and singular the said premises before mentioned unto the said Brandon Mill its successors and assigns forever. And the said Melville Land Company does hereby bind itself and its successors to warrant and forever defend the said premises unto the said Brandon Mill its successors and assigns, against it and every person whomsoever lawfully claiming the same or any part thereof.

Lease. Mrs. H.C. Poole and H.M. Shimate to

F.M. Simmons.

Mrs. H.C. Poole and H.M. Shimate lessor, in consideration of the rental hereinafter mentioned, have granted, bargained and leased, and by these presents do grant, bargain and release unto F.M. Simmons lessee, the Store #13 on the East side of South Main St, this being the same store that the said Simmons is renting at present and is running a restaurant in for the term of one year from Jan 1st 1904 with the privilege of three years at the same terms as the first year and the said lessee in consideration of the use of said premises for the said term, promise to pay the said lessor the sum of Four Hundred and twenty and no/100 Dollars per year payable \$35.00 Monthly on the first day of each month.

To have and to hold the said premises the said lessee his executors, administrators and assigns for the said term. It is agreed by the parties hereunto that this lease shall continue from year to year on the same terms, unless the party desiring to determine it give to the other party one month's written notice previous to the time of the desired termination but the destruction of the premises by fire or other casualty, or two months arrear of rent, shall terminate this lease. The lessee agrees to make good all breakage of glass, and all other injuries done to the premises during the term, except such as are produced by natural decay and unavoidable accidents, and agrees to make no repairs, improvements or alterations in the premises without the written consent of the lessor.
