

State of S.C. Lease. J.D. Pearson and wife to  
County of Greenville. T.M. Alexander.

This indenture made the 9th day of May 1905, by and between T.J. Pearson and wife of the County of Greenville and State of South Carolina, party of the first part and T.M. Alexander of the County of Greenville and State of South Carolina, party of the second part.

Witnesseth:-

I. That in consideration of the sum of one (1) dollar paid by the party of the second part to the party of the first part, the receipt whereof is hereby acknowledged, and the further consideration of Twenty (20) dollars per ton royalty, paid and to be paid by the party of the second part to the party of the first part for Monazite mined and to be mined on the premises herein below described and taken therefrom, the said party of the first part does hereby give, grant, lease and confirm unto the party of the second part, his heirs, executors, administrators and assigns, for a term of ten (10) years, beginning with the date of this instrument full and exclusive right to enter upon, possess and by agents and servants, the hereinafter described premises, and to mine, dig and carry away all Monazite that may be found thereon, with full liberty of ingress, egress and regress at all times to him the said party of the second part, his heirs, executors, administrators and assigns, and his and their servants, agents and workmen in and upon the hereinafter described premises, for the purpose of securing, working, getting and carrying away all Monazite located thereon and therein and generally to do all other acts and things necessary and proper for the working and getting the said Monazite, that is to say, upon the land and premises described as follows:

All the beds of the branches on T.J. Pearson's place joining lands of J.T. Campbell and W.C. Lenly and others on the waters off Reedy Fork Creek with right to make dams and ditches for mining sand.

This indenture made the 25 day of April 1905 by and between D.P. Pearson of the County of Greenville and State of South Carolina, party of the first part, and T.M. Alexander of the County of Greenville and State of South Carolina, party of the second part witnesseth:

I. That in consideration of the sum of one dollar paid by the party of the second part to the party of the first part, the receipt whereof is hereby acknowledged, and the further consideration of 10 dollars per ton royalty, paid and to be paid by the said party of the second part to the party of the first part for Monazite mined and to be mined on the premises herein mentioned below described and taken therefrom, the said party of the first part does hereby give, grant, lease and confirm unto the party of the second part, his heirs, executors, administrators and assigns, for a term of five years beginning with the date of this instrument, full and exclusive right to enter upon, possess and by agents and servants, the hereinafter described premises and to mine, dig take and carry away all Monazite that may be found thereon, with full liberty of ingress, egress and regress at all times to him the said party of the second part, his heirs, executors, administrators and assigns, and his and their servants, agents and workmen, in and upon the hereinafter described premises, for the purpose of searching, working, getting and carrying away all Monazite located thereon and therein and generally to do all other things necessary and proper for the working and getting the said Monazite, that is to say, upon the land and premises described as follows;

All that tract of land on the branch a right to carry on all works for monazite and every thing necessary on said land near as the Pearson farm Being on the head waters of Crane Creek bounded to the north by Alf Roseman, on the west M.C. White, on the east by Alf Walker and others.
