

State of South Carolina, Lense. William & Mamie Abraham to Greenville County. W.P.Chiles.

This indenture made the 26th day of April 1905 by and between William & Mamie Abraham of the County of Greenville and the State aforesaid-South Carolina, party of the first part, and W.P.Chiles of the County of Greenville and State of South Carolina, party of the second part, Witnesseth:-

I. That in consideration of the sum of One dollar paid by the party of the second part to the party of the first part, the receipt whereof is hereby acknowledged, and the further consideration of \$16.00 dollars per ton royalty, paid and to be paid by the party of the second part to the party of the first part for Monazite mined and to be mined on the premises hereinbelow described and taken therefrom, the said party of the first part does hereby give, grant, lease and confirm unto the party of the second part, his heirs, executors, administrators and assigns, for a term of 10 years beginning with the date of this instrument, full and exclusive right to enter in person and by agent and servants, the hereinafter described premises, and to mine, dig, take and carry away all Monazite that may be found thereon with full liberty of ingress, egress and address at all times to him, the said party of the second part, his heirs, executors, administrators and assigns and his and their servants, agents and workmen in and upon the hereinafter described premises for the purpose of searching for, working, getting and carrying away all Monazite located thereon and therein and generally to do all other acts and things necessary and proper for the working and getting the said Monazite, that is to say upon the lands and premises described as follows:-

All that tract of land on which William Abraham now resides and known as a part of the old James place situate in Gantt T.S. two miles west of Ready River Rd. and joining lands of Jackson Gantt, Obedia Pickett and others.

And the parties to this contract do bind themselves, their heirs, executors, administrators successors and assigns, to the carrying out and the execution of the said contract according to the terms, conditions and stipulations thereof.

This Indenture made the 25th day of Apr. 1905 by and between S.R.Roseman and his wife Fannie Roseman of the County of Greenville and State of South Carolina party of the first part and T.M.Alexander of the county of Greenville and State of South Carolina, party of the second part witnesseth:-

That in consideration of the sum of one dollar paid by the party of the second part to the party of the first part, the receipt whereof is hereby acknowledged, and the further consideration of 16.00 dollars per ton royalty paid and to be paid by the party of the second part to the party of the first for Monazite mined and to be mined on the premises herein below mentioned and taken therefrom, the said party of the first part does hereby give, grant, lease and confirm unto the party of the second part, his heirs, executors, administrators and assigns, for a term of Ten years, beginning with the date of this instrument, full and exclusive right to enter upon in person and by agent and servants, the hereinafter described premises, and to mine, dig, take and carry away all Monazite that may be found thereon, with full liberty of ingress, egress and address at all times to him, the said party of the second part, his heirs, executors, administrators and assigns, and his and their servants, agents and workmen, in and upon the hereinafter described premises for the purpose of searching for, working, getting and carry away all Monazite located thereon, and therein and generally to do all other acts and things necessary and proper for the working and getting the said Monazite, that is to say upon the land and premises described as follows:-

ALL THAT TRACT on which S.R.Roseman now resides and known as the Roseman farm and situate on waters of Green Creek and about 2 miles from Dean's Crossing and bounded on the North by Ed Roseman, South by Dave Roseman, East by McWhite and others.

The parties of the second part agree to pay for all damage that may be done by them or their workmen to any cultivated crops on said premises.

The parties to this contract do bind themselves their heirs, executors, administrators successors and the parties to this contract to bind themselves their heirs, executors, administrators successors and assigns, to the carrying out and the execution of the said contract according to the terms, conditions and stipulations thereof.
