Stansell of the County of Greenville and State aforesaid, and J.F. Stansell of the State of Georgia, in consideration of the sum of Nine hundred (\$900.00) Dollars to us in hand paid at and before the sealing of these presents by H.D. Stansell of the County and State aforesaid (the receipt whereof is hereby acknowledged) have granted, bargained sold and released, and by these presents do grant, bargain, sell and release unto the said H.D. Stansell all that certain piece, parcel and tract of land situate, lying and being in Oak-Lawn town-ship in the County of Greenville, State of South Carolina, about fifteen miles from the City of Greenville, S.C., on the Augusta Road, being known as the Stansell place and having the following described metes and bounds, to-wit; Beginning at a stone N. 84 1/2 E. 15 1/2 to a stone; thence S. 23 1/2 E. 16.58 to a stone; thence S. 85 W. 23.06 to a stone; thence N. 51 1/2 E. to the Beginning point, containing thirty (30) acres, more or less, and bounded by property of W.C. Lindley, J.M. King, W.E. Stone and Tract "A" of estate of F.G. Stansell this being tract "A" of estate of F.G. Stansell ex plat made by B.M. Milligan Surveyor August 26th., & 28th., 1905 being a part of the tract of land originally surveyed to Sarah Heit, by S.A. Townes, C.H.G.D. by his deed dated October 4th., 1852, and recorded in the office of R.M.C. for the County of Greenville in Book "W" at pages 548 and 549. It was next conveyed by W.T. Shumate, Sheriff, in the suit of Jas. H. Arnold against Sarah Heit, to James W. Stansell and his Heirs and Assigns forever, and we do hereby bind ourselves and our Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said H.D. Stansell and his Heirs and Assigns, against us and our Heirs, and against every person whatsoever lawfully claiming or to claim the whole or any part thereof.
