Whereas, I, Lily T. Ambler of the State and County aforesaid, on the 27th, day of February, 1906 conveyed to L.I. Jennings a certain lot of land in the City of Greenville on the North-west corner of North and Brown Streets, fronting forty-two (42) feet, nine (9) inches on North Street and having a depth of One hundred and ten and one-third (110-1/3) feet, bounded by North Street, Brown Street, a ten foot Alley at the rear and lot of Lily T. Ambler, guardian, (see deed recorded in R.M.C. office book R.R., page, 234 and correction of same in book M.M.M. page 682);

And whereas, at the time I executed and delivered said deed I owned only forty (40) feet front of said lot, there being a strip two (2) feet nine (9) inches front and One hundred and ten and one-third (110-1/3) feet in depth, the title to which at the time said deed was executed was in me as guardian of Arthur G. Goodwin and Nell G. Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or Appertaining. To Have and to Hold all and singular the said premises before mentioned unto the said L.I. Jennings-his heirs and assigns forever.
