(the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *J. A. Gilbreath* all my undivided one third interest of ground to all that certain piece, parcel or lots of land in the 8th Ward of the City of Greenville, S. C. having the following metes and bounds, i. That tract on North side of Birnie St. being part of lots 2, 24, 23 on plat made by H. J. Cook, D. S. of lands of Westfield estate and recorded in Deed Book R. L. page 61, R. M. C. office, Greenville County; beginning at stake on Birnie St. on line of Robert Redman's lot and running thence N. 60° 12' W. 300 ft. hence N. 28 1/2 W. to Southern Railway's right of way, thence along said right of way 300 ft. thence S. 39 1/2 W. to beginning containing two & 33 1/2 (2.33) acres, more or less, and being same tract of land conveyed to Mattie L. Heirs and Assigns, against *me* and *my* Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.


## Renunciation of Dower.
