(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Harriet Ann Brown All of my right title and interest in and to all that certain piece, parcel and tract of land situate lying and being in O'Neal Township, Greenville County and State aforesaid, on the North side of Frohawk Creek, of South Tyger River, Beginning at a white oak 3X 3X on bank of said Creek and runs N. 32 2/3 E. 12.77 to a stone 3 X thence N. 58 W. 26.75 to a post oak 3 X 3 X Thence S 8 1/4 W 27.35 to a red oak 3X 3X. on the north side of said creek, thence down Frohawk Creek to the beginning, containing forty three acres be the same more or less. Same land deeded to Ambros Green by Elijah Ballinger on the 27th. day of December 1858. and bounded by lands of W.D. Ballenger, S.D. Mos-teller, John West and others.
