WHEREAS, Zion Collins, late of the County and State aforesaid, did heretofore depart this life leaving of force his last will, which was duly admitted to probate in the office of the Judge of Probate on August 22, 1896, whereby among other things he devised his lands, including that hereinafter described unto Hezekiah Fleming, James O. Allen and Pickens Chappell on certain trusts set forth in said Will, all of said parties having accepted said trust, and the said Hezekiah Fleming having subsequently departed this life; and

WHEREAS, Rosalee Collins, named in said Will, did subsequently convey her interest in said lands unto James O. Allen; and John Collins referred to in said will did convey his interest in said lands to Julia Chappell; and

WHEREAS, the said Trustees and all the parties in interest have agreed upon a sale of the land hereinafter specified:

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, That we, James O. Allen and Pickens Chappell, as Trustees under the will of Zion Collins, deceased and Sarah E. Quattlebaum, ( formerly Collins), Catherine Camon (formerly Collins), Moses Collins, Pickens Chappell and James O. Allen ( to whom Rosalee Collins conveyed her interest) and Julia Chappell ( to whom John Collins conveyed his interest),- for and in consideration of the sum of One thousand Dollars (\$1000.00) to us in hand paid at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, have granted, bargained, sold released and conveyed, and by these presents do bargain, sell, grant, release and convey unto the said B.E. Geer, All those two certain pieces, parcels or lots of land situate, lying and being in the State and County aforesaid on the North side of Elkins Street, being known as Lots Nos. 2 and 3, on plat of sub-division of property of J.O. Allen and others, made on September 22, 1910 by R.E. Dalton D.S. to be recorded, and having the following lines, metes and bounds, to wit:-

BEGINNING at an iron pipe on the North side of Elkins Street, corner of Geer property and running; thence N. 13.55 E. One hundred and three (103) feet to an iron pipe, corner Lot No. 1; thence N. 13.55 E. eighty (80) feet and four (4) inches to an iron pin on McGee's line; thence South 69.03 E. One hundred and seven and 3/10 (107-3/10) feet to an iron pipe, corner lot No. 4; thence S. 9.15 W. one hundred and sixty-one and 1/10 (161-1/10) feet to an iron pipe on Elkins Street; thence with Elkins Street N. 80.45 W. one hundred and twenty (120) feet to the beginning corner.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said B.E. Geer, his heirs and assigns forever. And we do hereby bind ourselves and our heirs, successors, executors and administrators to warrant and forever defend all and singular the said premises unto the said B.E. Geer, his heirs and assigns, against us and our heirs and against every person whomsoever lawfully claiming or to claim the same or any part hereof.
