By the Secretary of State:

WHEREAS; John B. Marshall and W.E. Beattie, did on the 29th, day of March 1906, file with the Secretary of State a written Declaration, signed by themselves setting forth:  
First: The names and residences of the said Petitioners to be as above given,  
Second The name of the proposed corporation be that of Greenville Ice and Fuel Company.  
Third: the principal place of business of the Corporation will be Greenville, S.C.  
Fourth: the general purpose of the Corporation, and the nature of business it proposes to do Manufacture and sell Ice, Coal and Wood.  
Fifth: the amount of the capital stock to be Sixty Thousand dollars and the number of shares into which the same is to be divided to be Six Hundred of the par value of One hundred dollars each.

Sixth: the capital stock to be payable as set forth in the Declaration and Petition.  
AND WHEREAS; on 29th, day of March A.D. 1906 the date above named, petitioners were commissioned by me a Board of Corporators:

And Whereas, the said Board of Corporators on the 15th, day of August, 1906 did file with the Secretary of State their return in writing over their signatures, certifying among other things, that pursuant to publish notice as required in the Commission of the said Corporators, the books of subscription to the Capital stock of the aforesaid Company were duly opened, and that thereupon exceeding fifty per centum of the capital stock was subscribed by bona fide stockholders; that thereupon a meeting of stockholders was called and the aforesaid Company duly organized by the election of a Board of Directors, and other necessary officers. That furthermore they have complied with all the requirements of the Code of Laws of the State of South Carolina, of 1902 and all Acts or parts of Acts amenditory thereto.

Now therefore, I, J. T. Gantt, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amenditory thereto, do hereby certify that the said Company has been fully organized according to the Laws of South Carolina, under the name and for the purpose indicated in their written declaration, and that they are fully authorized to commence business underv their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance in each County where such Corporation shall have a business office.

This Indentre, between A.M. Garrett, the Lessors, and J.A. Massey and J.W. Massey the Lessees; WITNESSETH: that the Lessor agrees to lease to the Lessees for Agricultural purposes from 1st, day of Jan, 1906 to 31st, day of Dec. 1910 One hundred and twenty-five acres, (125), more or less situated in said County and in Grove Township, bounded by lands of Thos Hammon, Joel Ellison, L.C. Garrett and known as part of the old Chapman Place for the rent of the premises so leased the Lessee's agree to pay to the Lessor or Agt. two thousand lbs lint cotton (2000) lbs, yearly which rent shall become due, payable and delivered on or before 1st., day of Nov., in each year and the Lessees on their part agrees to take good care of the land and things leased especially of the ditches & terraces and to deliver possession of same at the expiration of this Lease, without further notice, and the Lessor also agrees in the year 1906----- and pay expenses of same, this agreement to bind the parties, their heirs, executors, administrators and assigns.
