(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Minie Plumley, A certain pease or parcel of land situated lying and being in the

State and county of a fore said and in the Glassy Mountain Township on the waters of Morgain Creek beginning at the bridge on Tugalo Rhoad that crosses Morgans Creek, thence Down Morgun creek near a S. E. course to tiger River thence Down said river to a stone corner at John Dills Lande thence with Dills Line Near said E. course to the branch to a stone corner Dills and Reaster. corner thence with the meanders of the branch to a stone 3x near the Rock spring thence up the old Rhoad to a stone corner by the Rhoad, thence with Dills land Near a N. corse to a stone 3x thence Near E. to a stone corner thence south to the rhoad to a stone 3x, thence with said Rhoad Near E with Dills line to a stone E X thence near N. with John Dills land to a Post Oak thence with said land to a stone E X George Centers corner thence a few feet to the Concorard school land to a stone E X, thence with said school land up the rhoad to a rock on the old Rhoad thence with the Rhoad to a stone E X, thence south west to a stone thence near S to a stone on old tugalo Rhoad, thence with said Rhoad to the Beginning Corner.
