(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Hattie Logen, all that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the West side of the Anderson road, just out side the Corporate Limits of the City of Greenville, having the following metes and bounds, to wit; Beginning at an iron pin corner of Anderson road and Sterling Street and running N. 50- $\frac{1}{2}$  W. 110 feet to a stake 3X nm; thence S. 56- $\frac{1}{4}$  W. Sixth-eight feet to a stake; thence S. 50- $\frac{1}{2}$  E. One hundred and ten (110) feet to corner on Anderson road; thence with said road N. 56- $\frac{1}{4}$  E. Sixty-eight feet (68) to the beginning corner, containing 6820 Sq. Ft., more or less, and bounded by Anderson Road, Sterling Street, lots No. 4 and 6 of Survey made May 6th, 1906, by J.N. Southern, the same being known and designated on said plat and survey as lot No. 3.
