Smith, his heirs, all that piece parcel, and tract of land, lying and being in Austin Township, County and State aforesaid, having the following metes and bounds, - Beginning at a Maple on North branch of Rock creek, , branch of Gilders Creek thence N. 64° W 2.61 to White Oak stump , thence N 58° W 15.88 to stone 3x, thence N 12° E. 4.73 to stake, thence S 3. 61 to Post oak, thence S 80° E 3.40 to Persimon, 3x, thence S 85° E 12.68 to Pine stump near Graveyard, thence S 22 1/2° W 12.89 to beginning corner, containing 15.89 acres more or less, and bounded by lands of W.H. Smith, Lee Smith and others.
