Campbell, all my entire interest in that certain piece, or parcel of land situated lying and being in the aforesaid State and County on ^{both} side of Blasingames Mill Creek the same being known as the Mill tract in the division of the real estate - of John Campbell joining lands of D.C. Lister P.O. Campbell N.B. Campbell and others in - cluding the Mill and all the attachments of whatsoever kind and containing forty acres, more or less,

TOGETHER will all and singular the Rights, Members, Heraditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said E.F. Campbell, his Heirs and Assigns forever

And I do hereby bind me and my Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said E.F. Campbell, his

Heirs and Assigns, against me and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
