demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 15th day of September 1908, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described: be conveyed by J. W. GRAY, Master in and for the County aforesaid, on the terms and for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; and the said Anita Earle Davis

having paid the sums of money mentioned in said decree, and in all respects complied with the conditions prescribed therein See Judgment roll 2895.

NOW, Therefore, Know all Men by these Presents, that I, J. W. GRAY, Master in and for the County of Greenville, aforesaid, in consideration of the performance of the conditions aforesaid, and the payment of One hundred twenty four and 67/100 Dollars, by the said Anita Earle Davis

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release, unto the said Anita Earle Davis all that certain piece, parcel or tract of land situate, lying and

being in Oak Lawn Township in the county of Greenville in South Carolina containing fifty eight acres more or less, being a part of the tract containing 195.15 acres more or less, conveyed to Edward I. Earle by J. W. Gray Master May 28th 1906, deed recorded in the R.M.C. Office in and for Greenville County in Book K.K.K. at page 192, beginning at an iron pin on Reedy Fork Creek, thence along line of Jas. G. Hopkins N. 36-3/4 W. 30.25 to a stone, thence S. 2-1/2 W. 12.70 to an iron pin, thence again on William Kellett's line S. 86-1/4 E. 11.10 to an iron pin; thence S. 16-1/2 E. 2.00 to an iron pin; thence on line of W. H. Massey S. 12 E. 1.60 to an iron pin, thence along same S. 60-3/4 E. 6.28 to a stone and iron pin; thence S. 26-3/4 E. 10.20 to an iron pin; thence along line of tract No. 2 of said estate, N. 74 E. 8.00 to a maple on Reedy Fork Creek, thence up the meanders of said creek along line of tract No. 2 of said estate to the beginning corner.

heirs and assigns forever.
