Hester, surveyor on the 12th, day of November 1910, containing twelve and a half acres (12-1/2) more or less and having the following metes and bounds, to wit: Beginning on a stone X, Berea School corner, and running; thence N. 4-1/2 E. 8.56 to a stake; thence N. 78 W. 12.15 to stone XNM; thence S. 21 W. 10.50 to stone XNM; thence S. 85 E. 14.88 to the beginning corner.
