the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release, unto the said F.M. King, all that certain parcel or tract of land situate in Dunklin Township,

County and State aforesaid containing thirty-five (35-1/2) and one-half acres, more or less, and known as tract No. four in the plat of survey of lands of Robert Scott, deceased and having the following metes and bounds, to wit; Beginning at a stone 3X0M, corner of tract No. three and running; thence N. 25 W. 18.77 to stone 3XNM; thence S. 65 W. 16.60 to Maple 3XNM on branch; thence S. 25-1/2 W. 13.40 to red oak 3XOM; thence S. 89 E. 6.92 to stone 3XOM; thence S. 21 E. 7.57 to W.O. 3XOM; thence N. 65 E. 19.54 to stone 3XNM at the beginning corner, all of which more truly appears in the above described plat of said tract of land made by James P.
