demanding judgment in relation to the real-estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 11th day of September 1909, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real-estate hereinafter mentioned and described, be sold by J. W. GRAY, Master in and for the County aforesaid, on the term and for the purposes mentioned in the said decree as by reference thereto on file in said Court, will appear; and the Master, after having duly advertised the said real-estate for public outcry on the 4th day of October in the year of our Lord nineteen hundred and nine

did then openly and publicly, according to the custom of auction, sell and dispose of the same unto Martha A. Pearson for the sum of Sixteen hundred and eighty Dollars, being at that price the highest bidder therefor.

NOW, Therefore, Know all Men by these Presents, that I, J. W. GRAY, Master in and for the County of Greenville, aforesaid, in consideration of the sum of Sixteen hundred and eighty Dollars, to me paid by the said Martha A. Pearson,

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release, unto the said Martha A. Pearson, all that certain parcel or tract of land lying, being and situate in County and State aforesaid, containing forty-two (42) acres, more or less, known as Lot No. 1 in the partition of the lands of F.W. Pearson, deceased and having the following metes and bounds to wit:

Beginning at a stone on branch; thence N. 66 E. 17.0, crossing the State road to an iron pin in line of road; thence with said road 6.50 to iron pin corner of lot No. 2; thence N. 40 1/2 E. 3.0 to a stone; thence N. 33 W. 6.55 to a stone; thence N. 54 W. 6.18 to a Sycamore; thence S. 52 W. 5.25 to a stake at intersection of State Road and road from Mush Creek Church; thence with last mentioned road S. 73-3/4 W. 12.75 to a stake in said road; thence along with said road S. 90-1/2 W. 7.30 to a black-gum on said road; thence S. 29 W. 1.14 to a branch; thence with the meanders of said branch 20.53 to beginning corner as shown by plat of survey made by B.F. Neves on the 20th, day of August 1909.

To HAVE AND TO HOLD, all and singular the premises before mentioned, unto the said Martha A. Pearson, her

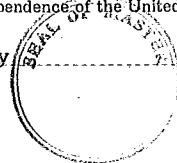
heirs and assigns forever.
