the receipt whereof is hereby acknowledged, ad. HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release, unto the said S.M. Vaughan, all that certain parcel or tract of land situate in Austin Township

County and State aforesaid, containing forty-three and one-half acres, more or less, known as Lot No. 1, in the plat of survey of the lands of John Thomas Vaughan, deceased and having the following metes and bounds, to wit: Beginning on a stone on Public Road and running; thence S. 88 E. 13.70 to double white-oak thence N. 4-7/8 E. 41.27 to post oak, thence S. 67-1/2 W. 15.00 to stone; thence S. 17 E. 12.22 to the beginning corner, bounded by lands of Arthur Todd, Tom Waters, Conner Vaughan, James McKinney and Tract No. 2.
