KNOW ALL MEN BY THESE PRESENTS, That I, J.T. Harris of Spartanburg County in the State aforesaid... in consideration of the sum of One thousand and fifty & no/100 Dollars to me in hand paid at and before the sealing of these presents by T.H. Reid of Greenville County, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said T.H. Reid, all that certain tract or parcel of land situate, lying and being in the aforesaid State and County, in Glassy Mountain Township, and same being the land deeded to me by J.L. Campbell, beginning on Post-oak stump (T.H. Reid's corner) on North side of Tugaloo Road; thence Southwesterly direction on North side of said Road about forty-two chains to stake in fork of Creek; thence down the Creek about seventeen chains to stone on bank of Creek, thence N. 51 E. 11.00 chains to W.O.; thence S. 44 E. 2.00 chains to stone; thence S. 74 E. 24.03 chs. to a stone; thence S. 11 W. 3.23 chs. to stone; thence N. 81 E. 22.60 chs to stone; thence N. 36 1/2 W. 47.00 chs to beginning, containing One hundred seven and one-half (107 1/2) acres, more or less bounded by lands of M.L. Davis, T.D. Davis Wm Henson, myself, E.F. Campbell & T.H. Reid,

TOGETHER will all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said T.H. Reid, his Heirs and Assigns forever.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said T.H.
