County aforesaid in Ward One of the City of Greenville, and having the following metes and bounds Beginning at an iron pin on Laurens Street at the Corner of Mrs. S.A. Williams lot; thence in a Northeasterly direction Sixty-one (61) feet on Laurens Street to an iron pin at the intersection of lots Nos. 6 and 7 on said Laurens Street; thence in a Northwesterly direction One hundred and eight & 2/100 (108-2/100) feet to the intersection of lots Nos. 4, 5, 6, 7; thence in a Southwesterly direction Sixty-one (61) feet on a line approximately parallel to Laurens Street to an iron pin at the intersection of Lots Nos. 7 & 8, and touching lot No. 3; thence One hundred and seven & 46/100 (107-46/100) feet to the beginning corner, this being Lot No. 7 on a Plat made by J.R.
