KNOW ALL MEN BY THESE PRESENTS, That I, Rebecca Woods

in the State aforesaid Five Dollars, in consideration of the sum of Belton Woods to me in hand paid at and before the sealing of these presents by (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and convey unto the said

Belton Woods, all that certain piece parcel or lot of land situated lying and being in the County of Greenville and State of South Carolina, near the incorporate limits of the City of Greenville, adjoining lot of Sam Williams, and having the following metes and bounds to wit; begining at a stake on Jenkins Street (formerly Williams Street) corner of the said Sam Williams lot and running thence with the said Jenkins Street, (formerly Williams Street) N 77 1/2 W. to a stake on corner Jenkins & Brockman Streets, thence along the said Brockman Street S. 12 1/2 W. 3.18 chains to a stake corner T.C. Gower's lot thence with the last named lot S. 77 1/2 E to a stake corner the said Sam Williams lot, thence with the said Sam Williams line to the beginning corner

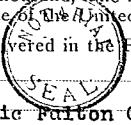

heirs and assigns, against me and my heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
