

- S. 56 W. one hundred and fifty feet to an iron pin on Norwood Street at joint corner of lots Nos. 10 and 11 on said plat; thence along Norwood Street N. 34 W. sixty feet to the beginning corner, and bounded by Lots Nos. 9, 8, 4 and 11 on said plat, and being known as Lot No. 10 on said plat.

Miller, his heirs and assigns against said persons who have executed and delivered to me said deed of trust as aforesaid and their heirs, and against myself and my heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
