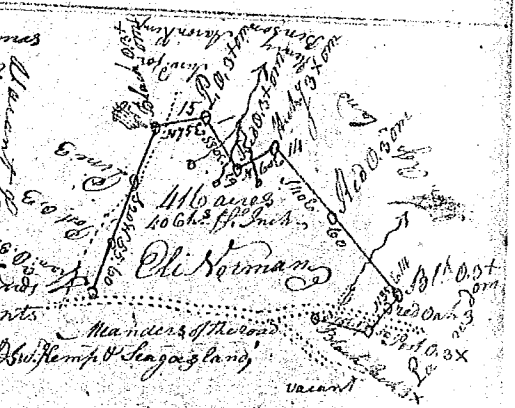


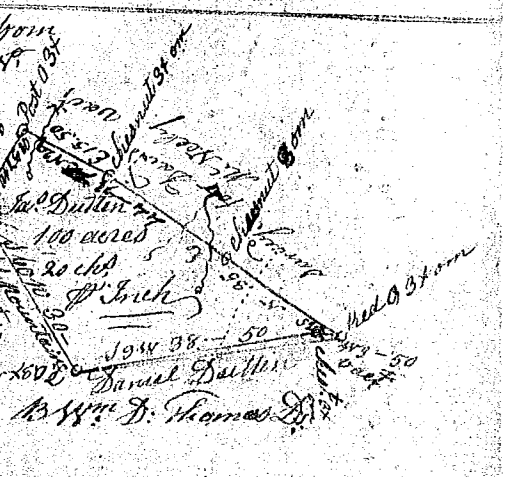
State of Carolina, Pursuant to a warrant from

 the Great Road leading from Greenville Court House to  
 Spartanburg 175 E. & N. E. by vacant unknown lands
