STATEMENT OF DEDICATION AND TRANSFER OF

We, the undersigned, do hereby state that we are duly authorized officers of Liberty Life Insurance Company corporation, and that said corporation is the owner in fee simple of the lands which it has caused to be subdivided into a subdivision named SouthChase as shown on a plat which is on file in the office of the County Planning Commission of Greenville County, and which upon approval by said Commission will be recorded in the office of the County Register of Mesne Conveyance.

NOW, THEREFORE, KNOW ALL MEN, that the corporation freely offers and dedicates to those who may purchase said property or any part of it, to the general public and to local authorities who have responsibility for maintenance, the use and control of the streets and roads shown on said plat of property for public use.

The property shown on said plat is not encumbered by a mortgage, judgment, or other lien or encumbrance, except: for Protective Covenants and mortgages of record from which said property to be dedicated shall be released prior to acceptance by the County.
