WHERAS,

in the full and just sum of Five Hundred (500<sup>00</sup>)  
Dollars, to be paid John W. H. Herndon

with interest thereon from July 1st at the rate of Eight per cent. per annum to be  
computed and paid quarterly

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note..... to become immediately due, at the option of the holder hereof, who may  
suit thereon and foreclose this mortgage, said note further providing for an attorney's fee of One percent of the  
amount due and unpaid..... besides all costs and expenses of collection, to be added to  
the amount due on said note..... to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note..... reference  
being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That ..... the said Mary E. Latimer  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

according to the terms of the said note....., and also in consideration of the further sum of Three Dollars, to ..... the said  
Mary E. Latimer

in hand well and truly paid by the said John W. H. Herndon  
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said John W. H. Herndon

all that certain piece parcel or lot of land situate,  
lying and being on Rutherford street in Ward one  
of the City of Greenville and County of Greenville and  
State of South Carolina, and having the following  
metes and bounds, Beginning at an iron post on  
Rutherford st. sixty feet from Earle street and run-  
ning thence in a line parallel with Earle st. S. 85<sup>1/4</sup> E.  
170 ft. and quicke to iron post, thence S. 2<sup>1/4</sup> W. 92 ft.  
to an iron post, thence N. 84<sup>1/4</sup> W. 170 ft. and three  
inches to iron post on Rutherford street, thence with  
Rutherford street N. 2 E. 88 feet to the beginning corner.  
Also, all that piece, parcel or lot of land adjoining  
above-described lot of land and having following  
metes and bounds, Beginning at an iron post on  
Rutherford street thence with line of above-described  
lot S. 84<sup>1/4</sup> E. 170 feet & 3 inches to iron post thence S.
