interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten percent.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said J. P. Ballenger,

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said J. P. Ballenger,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said J. P. Ballenger,

All that certain piece, parcel and lot of land

of residencie, Greenville County, near Wighttower
Mill, and being recorded as "lot No. 120
S. Fifty feet front, 250' deep, in part of said property
recorded in G. M. C. office for Greenville County

a stake on an unnamed street, corner corner
lot No. 131 and running back up a called
line due hundred forty five (135) feet, and
being fifty feet on the rear line. Bounded for
lots Nos. 119 and 131, on said plat. Being the
