with interest thereon from March 1919 at the rate of 8 per cent. per annum to be  
computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent

besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said James M. Richardson

all that certain piece, parcel and tract of land  
in the County and State aforesaid and contain-  
ing 218.76 acres, more or less, and being the  
same conveyed to Jas. M. Richardson and  
J. D. Lanford by deed dated April 11th. 1918 and  
recorded in the Office R. M. C. for Greenville  
County in Book 52 at page 224, and also  
being the same in which said Jas. M. Richardson  
this day conveys his interest to said  
J. D. Lanford, reference to the two said Deeds  
being made for fuller descriptions, and  
said lands being bounded by lands of  
T. H. Reid, Webb Wance, D. Evans, Tom Bellew,  
and others.
