SEND GREETING:

WHEREAS, I, the said J. L. McDowell, in and by my certain power of attorney, in writing, of even date with these presents, A.D. 1918, am well and truly indebted to

Chandles (or) in the full and just sum of Five hundred and fifteen (\$515.00) Dollars, to be paid as follows: the sum of twenty-five (\$25.00) dollars on December 10th, and annually thereafter at five (\$25.00) Dollars on the 1st day of each + every year thereafter until the full amount of the note + more, together with interest thereon from the date of the note at the rate of per cent. per annum to be computed and paid

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten percent

besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being made thereto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said W. A. Chandles,

all that certain lot or parcel of land just beyond the northern limits of the City of Greenville in the County of Greenville, State of S. C. known as lot No. 9 of the Kenep property, and described as follows, Commencing at iron pin South side Fair Street corner of lot 10; thence S. $\frac{1}{4}$ E. 284 feet to iron pin on right of way S. + L. R. R; thence N. 81 E. 152 feet along said right of way to an iron pin, corner of lot No. 7; thence N. $\frac{1}{4}$ W. 260 feet to an iron pin South side of Fair Street; thence S. 83 $\frac{3}{4}$ W. 150 feet along Fair Street to the beginning corner containing 93 $\frac{1}{100}$ of an acre and being the same lot conveyed to me by Abbie E. Donald by her deed dated October 2nd 1918.
