with interest thereon from the 1st day of May 1922 at the rate of eight per cent. per annum to be
computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten per cent

the amount due on said note to be collected as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference
being thereunto had, as will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said J.A. Mahaffey

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said Malinda Bomar

in hand well and truly paid by the said J.A. Mahaffey

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said J.A. Mahaffey, all that certain piece, parcel or lot of land

situate, lying and being in the said State and County aforesaid, in Chick Springs
Township, near the City of Greer, adjoining lands of Leona M. Brockman, myself and
others, and being part of the same land conveyed to Lee McMakin by Jackson Green,
deceased by deed bearing date of Aug. 1st, 1908 and having the following metes and
bounds: Beginning at an iron pin on an extension of Line Street and runs thence N. 82-1/4
W. 149 feet to back corner of Leona M. Brockman's lot; thence along the line of Leona M.
Brockman's lot S. 3/4 W. 94.6 feet to iron pin on said line; thence N. 87 E. 146.8 feet
to an iron pin on said extension of Line Street; thence with said Street N. 3 E. 80 feet
