on the first day of each and every month thereafter  
until the full amount of this note with interest is paid  
with interest thereon from date at the rate of eight per cent. per annum to be  
computed and paid annually

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, and note (other providing for an attorney's fee of ten per cent

besides all costs and expenses of collection, to be added to

on the northwest corner of Beattie and Mt. Zion  
Streets, and having a frontage on Beattie Street

five feet on the north side, and a width of  
forty-six feet on the back on Mt. Zion Street,
