WHEREAS, *C. M. White* the said *C. M. White*  
in and by *Valaree Rickman* certain *promissory* note in writing, of  
even date with these presents, *am* well and truly indebted to

in the full and just sum of *Valaree Rickman*  
Dollars, to be paid *to Valaree Rickman* *(\$1000.00)*

with interest thereon from *Valaree Rickman* at the rate of *eight* per cent. per annum to be  
computed and paid *to Valaree Rickman*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *ten per cent of the*  
*amount due upon said note* besides all costs and expenses of collection, to be added to  
the amount due on said note to be collected as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That *C. M. White*  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said  
*Valaree Rickman*  
according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me*, the said

*Valaree Rickman*  
in hand well and truly paid by the said *Valaree Rickman*  
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said *Valaree Rickman*

accept that piece or lot of land situate, lying  
and being *in Greenville County and State aforesaid,*  
about two miles west of the City of Greenville,  
and being a portion of a sub-division known  
as "City View"; Beginning at stake at north-  
east corner of Henderson and Queal streets  
and running thence N. 0-30 E. 150 feet to a stake  
corner of lots nos. 39 and 40; thence S. 89 1/2 E. 150  
feet to a stake on a ten foot alley; thence  
along said alley S. 0-30 W. 150 feet to a stake on  
Queal street; thence along said Street N. 89 1/2 W.  
150 feet to the beginning corner, and being  
composed of three lots, designated as lots nos.  
37, 38 and 39, as shown by a plat made by  
W.A. Adams, Surveyor, said Plat is recorded  
in the R. M. C. office for Greenville County,  
being the same lots of land conveyed to me  
by W. T. Henderson and T. J. Hunt by deed  
dated December 5th. 1918.
