at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,

bargain, sell and release unto the said Planters Savings Bank of Greer and its

Successors and assigns, all that certain piece parcel and tract of land, lying and being situated in the County and State aforesaid and containing more or less than one hundred and eight acres, more or less and being made up of Lots 3 and 4 on a plat made by Will D. Nevers to E. Nov. 17th 1910, which tract of land is described on said plat as follows: beginning at an iron pin in Blind Tiger Road and running thence with the meanderings of said road to an iron pin in same at corner of tract no. 2, thence N. 69-30 W. 32.50 to stake on South Tyger river, thence with the meanderings of said river to stake, thence S. 36-30 W. 43.10 to iron pin in Blind Tiger Road, aforesaid at beginning corner said land bounded by McMillan, tracts nos. 1 and 2 on said plat and on South Tyger river, and being the same conveyed by David D. Sanders as Trustee to John H. Gilreath and by said Gilreath this day to me.
