WHEREAS, I, the said D. L. Williams  
in and by one certain Gertrude P. Harrison note in writing, of  
even date with these presents, same well and truly indebted to

in the full and just sum of Two Thousand  
Dollars, to be paid one year after date

with interest thereon from date at the rate of 7 per cent. per annum to be  
computed and paid annually

until paid in full; all interest not paid when due to be an interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of 5 per cent of amount  
due besides all costs and expenses of collection, to be added to

the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said Gertrude P. Harrison

All that certain parcel or lot of land situate in the  
City and County of Greenville South Carolina on the South  
side of East Washington street, beginning on said  
Street at an iron pin opposite the intersection of  
Williams Street and run thence S. 15 E. 175 feet to  
iron pin, thence S. 15.49 E. 139.5 feet to an iron pin on  
right-of-way of C. & W. C. Railway, thence eastward  
along said right-of-way parallel with the track of  
said railway and at all times twenty five feet from  
the center of same 43.7 feet to an iron pin on said  
right of-way, thence N. 15-49 W. 27.3 feet to an iron pin,  
thence N. 15 W. 175 feet to an iron pin on South side  
of East Washington Street, thence S. 69-10 W. 73 feet  
to beginning corner, being the same lot of land  
deeded to me this day by Gertrude P. Harrison
