WHERAS, I, the said *H. Kelley D. Lauter*,
in and by *me* certain note in writing, of
even date with these presents, *me* well and truly indebted to

James B. Irvin
in the full and just sum of *Four Hundred*
Dollars, to be paid *the year from date*

with interest thereon from *January 1st, 1921* at a rate of *6* per cent per annum to be
computed and paid *quarterly*

until paid interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *16 per cent*

besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said *James B. Irvin*

that lot of land lying situated and being in the
City and County of Greenville and State aforesaid
in Ward 6 and being Lot 220.6 of a plat made by
J. V. D. Greer, C. E. Jan. 9th. 1911 and recorded in Vol.
C. page 200 in Recorder's office for Greenville, S. C.
and having the following metes and bounds to
writ: Beginning at the corner of lot 220.5 on Wilkins
St. and running S. 87-35 E. with Wilkins St.
fifty feet to corner of lot 220.4 thence with lot
220.4 N. 60-3-15 W. one hundred seventy feet six inch
to corner of lot 220.4 on Dix May St. thence N. 86-15
E. fifty feet with Dix May St. to corner of lot 220.5
thence with lot 220.5 one hundred seventy feet
