bargain, sell and release unto the said Berry Garrett, and his heirs and assigns, all that certain

Township and State aforesaid, containing seventeen and eight tenths acres, more or less
and having the following metes and bounds, to-wit: Bounded by lands of H.S. Wood,

thence N. 40-3/4 W. 15.72 to a stone; thence N. 30-1/2 E. 1.22 to a stone; thence N. 68-1/2
