until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent of amount  
due besides all costs and expenses of collection, to be added to  
the amount of said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had as will more fully appear.

hundred and thirty feet to a stake; thence S. 88 1/2 E  
seventy-four feet and three inches to a stake; thence N.  
5 E. two hundred and twenty-eight feet and six inches  
to a stake; thence N. 84 1/2 E. seventy-four feet and three  
inches to the beginning stake; being the same lot of  
land conveyed to me by George J. Bice by deed dated
