SEND GREETING:

WHEREAS, I, the said H. D. Carter
in and by my certain promissory note in writing, of
even date with these presents, I am well and truly indebted to

Chicora Bank, Pelzer, S. C.
in the full and just sum of One Thousand Hundred Thirty Six (\$1936.)
Dollars, to be paid

the day of October 1922
with interest thereon from January 1st 1922 at the rate of 8 per cent. per annum to be
computed and paid which may be cashed

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee

besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said Chicora Bank, Pelzer, S. C.

All that certain piece, parcel or tract of land situated,
lying and being in the state of South Carolina,
County of Greenville, Oaklawn Township, about two
miles south of the town of Pelzer on both sides
of the Pelzer and Cooley Bridge road, known and
designated as tracts 2 & 9 10 of the estate of
Mrs Narcissa N. Anderson, based on a plat thereof
made by E. Hawes, Jr. November 20th. 1913, recorded
in the office of R. M. C. Greenville County S. C.
in plat book E page 74 to 77 inclusive.
The four tracts hereby conveyed containing
collectively one hundred forty-nine (149) acres
more or less. This being the same land deeded
on July 16th. 1919 by Albert M. Anderson, executor
to H. D. Carter.
