sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

10% on amount due

besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said H.P. McGee, All that certain piece, parcel and tract of

land situate, lying and being in the State and County aforesaid in Bates Township on  
Saluda River and about eighteen miles from Greenville Court House, having the following  
metes and bounds: Beginning on South Saluda River at mouth of ditch; thence N. 1-<sup>1</sup>/<sub>4</sub>  
W. 39.87 to stone on road; thence N. 70 E. 8.00 to stone on branch; thence up branch  
11.70 to a sycamore; thence N. 29-<sup>1</sup>/<sub>2</sub> W. 1.59 to stone; thence N. 18 E. 21.15 to willow  
thence up branch 9.50 to W.O. at head of branch; thence N. 14 W. 3.68 to a stone on  
old road; thence N. 81 E. 3.56 to stone; thence N. 36 E. 5.65 to stone on old line;
