WHERAS,

in and by *W. C. Powers* the said *A. C. R. Hodder*
even date with these presents, certain sum of money

well and truly indebted to *W. D. Garrison*

in the full amount sum of *\$1,350.00* One Thousand and Three Hundred and Sixty (\$1,350.00)
Dollars to be paid *payable at 1st. 1919, 1st. 1919, and 1st. 1919*
and the first day of January 1920 until December 1st. 1919 at which
time the principal amount \$1,350.00 and \$35.00 on the interest of each and every
month thereafter to January 1st. 1921, at which time the full
amount of balance due and payable.
with interest thereon from *January 1st. 1919* at the rate of *one per cent. per annum to be*
computed and paid *until paid or sold; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or*
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
*sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent.**

besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *W. C. Powers*, the said *W. C. Powers*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said *W. D. Garrison and G. C. Powers*

All that certain piece, parcel or lot of land situate,
lying and being in Ward One of the City of Green
ville, County and State aforesaid, and on the
Southwest side of Hampton Avenue.

Beginning at an iron pin 203 feet North
of Frank Street, corner late lots 3 and 4, and run-
ning thence South Hampton Avenue N. 32° 25' W. 51
feet to an iron pin corner of lot 420.5; thence S. 57° 35'
W. with line of lot 420.5 140 feet to an iron pin on
a ten foot alley; thence S. 32° 25' E. 31 feet to an iron
pin rear corner lot 420.3; thence W. with line of lot
420.3, N. 57° 35' E. 140 feet to Hampton Avenue the begin-
ning corner. Being lot 420.4, of a plat of said lot
as shown on plat of G. C. Powers' property, recorded
in Plat Book "C" page 43, of the R. M. C. office
for Greenville County, and being the same lot of
land conveyed to me this day by the said *W. D.*
