SEND GREETING:

WHEREAS, I, the said Alex Cagle
in and by my certain promissory note in writing, of
even date with these presents, well and truly indebted to

The Fourth National Bank of Greenville, South Carolina
in the full and just sum of One Thousand and Fifty-two and 32/100 (\$1,062.32)
Dollars, to be paid sixty days after date

with interest thereon from date at the rate of 8 per cent. per annum to be
computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent of the
amount due hereon besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference
being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That the said Alex Cagle
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said The 4th Nat'l. Bk.
of Greenville, S.C. according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said

Bank of Greenville, S.C. at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said The Fourth National Bank of Greenville, S.C.

All of my right title and interest, estate, claim and demand whatsoever, both at law and in equity, in and to the real estate known as the Cagle Block on the north west corner of Main Street and McRee Avenue in the City of Greenville, in said County and State a share in the rents of which was bequeathed to me by the sixth item of the will of my father, Jacob W. Cagle, which bears date the 11th day of August 1916, and admitted to Probate by the Probate Court for said County and State on the 23rd day of December 1916, and now on file in the office of said Court of Probate in Apartment 102, File 5, and I hereby transfer, assign, set over and in plain and open market deliver to said grantee and its successors and assigns, all my interest in the rents or income from said property, and I do hereby direct Luther M. Nessee, G. W. Cox and Wilkine Cagle, the Executors and Trustees of said will, to pay to said mortgage or its assignee, any rents or income or other money which may be hereafter coming to him from said property under said will, until the debt hereby secured shall be paid in full with interest and attorneys' fees if any
